IN NEW YORK, THE NYC DEPARTMENT OF EDUCATION EXPANDED SAGA'S WORK FIVEFOLD FROM ITS INITIAL PILOT DEMONSTRATION PROJECT (WHERE SAGA SERVED 130 STUDENTS IN ONE SCHOOL), TO PLACE SAGA IN 5 SCHOOLS SERVING 680 STUDENTS. THE NY CITY CONTRACT WAS AWARDED FOR A TWO YEAR TERM, TO SEE I SAGA COULD DEMONSTRATE ITS MODEL. IN CHICAGO, SAGA SERVED 800 STUDENTS IN 11 DISTRICT HIGH SCHOOLS.
